2018 Texas State Indoor Championship



This year's LoneStar Classic will be a super fun event, a great tournament for preparing for indoor nationals, and part of the 2018 Texas State Indoor Championship series. If you choose and are a Texas resident, then your scores can be combined with Texas State Championship events held at locations around the state, to determine the Texas State Champion Archers. Medals for State Champion Archers will be mailed separately.

LoneStar Classic Indoor (Star Fita) *"You don't have to be a Texas Resident"*

Belt Buckles awarded for top 3 in each division. All Joad participants will be recognized.

Hosting Facility: Cinnamon Creek Ranch

WHEN: February 3-4, 2018

WHAT: Adult Lines: A double FITA I (60 arrows at 18 meters on a 40 centimeter face) at two separate times for adults and youths shooting the adult round.

JOAD Line: All archers will shoot a single FITA I (60 arrows at 18 meters), except Yeoman (30 arrows at 9 meters on a 60cm target face). All compound archers will shoot a 40cm target face (All compound archers score inner 10-ring). For Recurve archers: Bowman and Cubs will shoot a 60cm target face; Cadets and Juniors will shoot a 40cm target face.

WHERE: The 2018 LoneStar Classic will be held at Cinnamon Creek Ranch. Cinnamon Creek Ranch is located at 13794 Old Denton Rd. Roanoke, TX 76262.

SHOOTING TIMES: JOAD line -Saturday at 1 p.m.
All other divisions: (Choose two of the following) Saturday 9 a.m., Saturday 6 p.m.,
Sunday 9 a.m.

COST: \$58 for the double FITA I portion; \$45 for the JOAD single FITA; \$5 for Scores being included in State Championship Series.

ENTRY DEADLINE: January 25th, 2018. Late registration 1/27 to 1/29 an additional \$15
Entries will be accepted on a space available basis after the deadline with a \$15 late fee. Space on each line is limited, so get your entry in early to be guaranteed a time slot. If payment is not received by then, the space will be given to people on the waiting list if there is a waiting list at that point.

*Novice Division is for those who are collegiate archers that have been shooting for only 1 year or less. All other collegiate archers with more than 1 year experience must register in their appropriate junior/senior division. (If you want to shoot in an unlisted division, just let me know and we will add it).

AGE Classifications Yeoman through 8th year of age (shoot 9 meters)

Bowman through 12th year of age
Cub through 14th year of age
Cadet thru 17th year of age
Junior thru 20th year of age

PHOTO RELEASE

In consideration of me being allowed to participate in any way in any "Activity" with The National Archery Association (USA Archery) of the US, I agree to the following:

1. I UNDERSTAND DANGERS may be caused by my own actions, or inaction's, the actions or inaction's of others participating in the Activity, and the condition.

I understand the nature of the activities and acknowledge my experience and capabilities and believe I am qualified to participate in such Activity. I further acknowledge that I am aware that the activity will be conducted in facilities open to the public during the Activity. I further agree and warrant that if, at any time, I believe conditions to be unsafe, I will immediately discontinue further participation of the Activity.

2. I FULLY UNDERSTAND that activities involve risks and dangers of SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH ("Risks"); These Risks in which the Activity takes place or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW;

c. There may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES incurred as a result of my participation in the Activity.

3. I HEREBY RELEASE, DISCHARGE, COVENANT NOT TO SUE, AND AGREE TO HOLD HARMLESS North Dallas JOAD, their respective administrators, directors, agents, officers, volunteers, and employees, Cinnamon Creek Ranch, their respective administrators, directors, agents, officers, volunteers, and the tournament organizers and volunteers, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place (each considered one of the "Releasees" herein) from all liability, claims, demands, losses, or damages on account caused or alleged to be caused in whole or in part by the negligence of the "Releasees" or otherwise, including negligent rescue operations and further agree that if, despite this release, I, or anyone on my behalf makes a claim against any of the Releasees named above, I WILL INDEMNIFY, SAVE AND HOLD HARMLESS EACH OF THE RELEASEES FROM ANY LITIGATION EXPENSES, ATTORNEY FEES, LOSS LIABILITY, DAMAGE OR COST ANY MAY INCUR AS THE RESULT OF ANY SUCH CLAIM.
